

EXECUTIVE DIRECTOR

It shall be the policy of the State Board for Technical and Comprehensive Education to recognize the designated service areas for each technical college, as delineated in the accompanying table. The Board further holds that all activity in a designated service area which falls within the prescribed mission of Tech as mandated by public law, shall be the responsibility of the respective area commission and technical college.

Procedures shall be established to provide for cooperative agreements for colleges to conduct programs across service areas.

Any programs that are conducted without the requisite inter service area agreement will be credited with respect to statistical value and funding to the technical college responsible for the affected service area.
